



Pursuant to part VI of the Central Bank Act 2020, the Central Bank of the Bahamas serves as the Registrar to the Bahamian Government and issues Bahamas Registered Stocks (BRS) on its behalf.

This Bahamas Registered Stock Purchase Application serves as a Purchase Agreement between the Central Bank of The Bahamas, on behalf of the Bahamian Government, and the purchaser(s).
