CENTRAL BANK OF THE BAHAMAS ACT (CHAPTER 351)

CURRENCY (NOTES AND COINS) (AMENDMENT) (NO. 2) ORDER, 2018

The Minister, in exercise of the powers conferred by section 13 of the Central Bank of The Bahamas Act, after consultation with the Bank, makes the following Order—

1. Citation.

This Order, which amends the Currency (Notes and Coins) Order (S.I. No. 112 of 2013), may be cited as the Currency (Notes and Coins) (Amendment) (No. 2) Order, 2018.

2. Amends First Schedule to the principal Order.

The First Schedule to the principal Order is amended —

- (a) in item 6, by inserting, immediately after paragraph (d), the following
 - "(e) Predominantly tan, with shades of burgundy, brown, red, lavender, and yellow, the note measures 156mm long and 67mm wide bearing on the front a portrait of Queen Elizabeth II, the series, and the signature of the Governor of The Central Bank of The Bahamas, together with the words "The Central Bank of The Bahamas. These notes are legal tender under The Central Bank of The Bahamas Act, 2000 for the payment of any amount Three Dollars". A watermark of Queen Elizabeth II and numeral \$3, a replica map of the islands of The Bahamas, and the denominational value in words and figures appear on the left, with an image of a Passion flower in the centre. The back features images of sail boats at sea. The images are flanked above by the numeral \$3 that appears in the upper left and lower right corners, while the words "Three Dollars" are in the upper right quadrant. Just below the images of sail boats is the Coat of Arms of The Commonwealth of The Bahamas along with the words "Central Bank of The Bahamas"."; and
- (b) in item 9, by inserting, immediately after paragraph (e), the following —

"(f) Predominantly grey, with shades of green, blue, coral, lilac and red, the note measures 156mm long and 67mm wide bearing on the front a portrait of Queen Elizabeth II, the series, and the signature of the Governor of The Central Bank of The Bahamas, together with the words "The Central Bank of The Bahamas. These notes are legal tender under The Central Bank of The Bahamas Act, 2000 for the payment of any amount Fifty Cents". A watermark of Queen Elizabeth II and numeral \$1/2, a replica map of the islands of The Bahamas, and the denominational value in words and figures appear on the left, with an image of a Strongback flower in the centre. The back features a vignette of Sister Sarah in the Straw Market. The vignette is flanked above by the numeral \$1/2 that appears in the upper left and lower right corners, while the words "Fifty Cents" are in the upper right quadrant. Just below Sister Sarah is the Coat of Arms of The Commonwealth of The Bahamas along with the words "Central Bank of The Bahamas".".
